

UNIVERSITY LUTHERAN CHAPEL PARKING REGULATIONS AND APPLICATION

In exchange for the use of a parking space in the parking lot of the University Lutheran Chapel (ULC), I agree to the following:

I will not park in the lot on special occasions, such as weddings, as notified by the Chapel. **I ALSO WILL NOT PARK IN THE LOT ON SUNDAYS BETWEEN THE HOURS OF 9 A.M. AND 2 P.M.** I understand that if my car is parked in the lot during these times I will be fined \$20. If I do not pay by 5pm the following Sunday, I will owe an additional \$20 and will be **DENIED ACCESS TO THE LOT UNTIL I PAY THESE FINES.**

I will keep the ULC grounds and parking lot free of litter.

I will NEVER park in the driveway, or I will be booted or towed.

I will NEVER park in the spaces reserved for the Pastor, Campus Ministry Associate, or LINC even if all other spots are full, or I will be booted or towed.

If I get a new license plate number, I will immediately notify the Chapel Parking Coordinator via email, ulcbruins@gmail.com AND leave a note on my car, as well as under the Chapel office door.

I will not share my parking rights with anyone. I MAY NOT SUBSTITUTE another vehicle for the one I have registered with the Chapel.

I agree to pay the University Lutheran Chapel \$165 per summer session for parking privileges. **THIS WILL BE PAID IN CASH or through PayPal.** I recognize that if I fail to abide by these regulations, my parking rights may be terminated by the ULC.

I agree that while on ULC property, I will abide by all laws set forth by the State of California and/or the Federal Government.

I RECOGNIZE THAT BY SIGNING THIS CONTRACT I WILL MAKE THE PAYMENT FOR PARKING PRIVILEGES, REGARDLESS IF I USE THE PRIVILEGES OR NOT.

I recognize that by signing this contract, I will give sufficient amount of time (at least two weeks prior to the start of the quarter) to submit written notification to parking coordinator that I will not be paying or using my parking privileges for that quarter or the remainder of the contracted time.

THIS CONTRACT LIMITS OUR LIABILITY. PLEASE READ IT!

This contract licenses the signatory to park one vehicle in this area at the indicated amount. The signatory acknowledges that the University Lutheran Chapel (ULC) is not liable for fire, theft, damage, or loss to any vehicle, regardless of the party or the property that may cause such damage. All property left in the vehicle is left at the owner's risk.

Only a rental of space is created hereby, and no bailment is created.

The signatory agrees to obey the rules and regulations set by management regarding the issue of parking spaces.

The University Lutheran Chapel (ULC) may alter the terms of this agreement at any time. Upon establishing such a change, the signatory will be provided with a copy of the revised agreement. The signatory will have five (5) days to sign and return the revised agreement to ULC. If the signatory elects not to sign the revised agreement, then ULC shall return to that signatory a check in the amount equal to the share apportioned to the number of days remaining in the term as previously stated in this agreement, and parking privileges will be terminated.

Signatory acknowledges that the University Lutheran Chapel (ULC) has the right to terminate an individual's parking privileges for any reason satisfactory solely to ULC. If ULC elects at any time to terminate the parking privileges of the signatory, ULC will provide five (5) days written notice, and shall return to that signatory a check in the amount equal to the share apportioned to the number of days remaining in the term as previously stated in this agreement.

By signing this portion of the application the contractor agrees to abide by the rules stipulated in the attached sheet, "University Lutheran Chapel Regulations and Application." Furthermore, the contractor acknowledges that he/she has read these rules and understands the provisions.
